 - Connie Certifications and what they mean are not clear to people who do not know what they mean
 - Proposal will eliminate the letters/"alphabet soup" and will say "Certified Member since ____"
 - Certified and Associate
 - Certified Has RID

- Associate Not yet achieved/actively pursuing cert
- Currently there is no formal screening for some positions
 - Now proposing that RID requires proof of certification to be on the registry
 - Qualifications:
- Connie Should only list Certified on registry, not associate
 - Only Certified Interpreter's on Registry All agree
- o Reid Question about legal certification
- Antwan Testing New test supposed to be available end of January possibly
 - Written, Ethical, and Performance
 - No talk about cost
 - Old test is still available
 - Recognition of outside test
 - NCCA Accreditation Process involved pending
 - EIPA not currently recognized because there is no CE/CEU process
 - If it follows RID's CMP Process, it will be passed
 - BEI potential to pass

FCC Letter

- Purple Charlotte Center is hiring unlicensed interpreters
- Asked to write a letter to inform the FCC about this incident
- Letter has been written Antwan read letter
- Connie Request for names to be sent to NCITLB
- Rachel contacted NCITLB and NCITLB has had already received these complaints and NCITLB has said there is nothing they can do because federal law supersedes state law
- Connie has had to get licenses in other states to do VRI work
 - Disagrees with NCITLB
 - Suggests to send this letter out and post as an open letter use social media
- Rachel called Purple and was told they would "look into it"
- Sending more letters
 - Send letter to Purple Headquarters
 - Post FCC letter to website and social media
