RID Update:

- Moving from a membership organization to a professional organization
- Has been an interesting few months, Antwan will keep everyone informed and will update everyone in August regarding the RID national conference
- Change from Membership to Professional organization was supposed to be an official motion at the national conference, instead that decision has been made to move forward with that change without membership involvement/voting

Mark Lineberger – NCRID Representative for NCITLB

- All board members introduced themselves and their role on the board
- Introduction: interpreting over 20 years in multiple settings, mentoring and training, fully licensed through NCITLB since 2006, has NIC Advanced from RID, grew up in Morganton, NC, honored to be appointed to represent this body, for interpreters we provide communication equity so our individual goals should be to advance our knowledge and skills, when a consumer sees our license they should be confident we are qualified
- Goals:
 - path to licensure, path to provisional license
 - Certifying bodies will be accepted for licensure
 - Provisional licensing renewal system (need a more robust and structured system), need a cap on provisional renewals
 - Agency accountability: interpreters largely monitor themselves and agencies need to be held more accountable for the interpreters they send to assignments
 - Educational Interpreters: enhancing the standard
 - Post-Secondary Education: many interpreters remain hidden there and do not become fully engaged in the profession/licensing process
- Discussion
 - Antwan report the updates and changes that are coming
 - Mark will report to the NCRID board after all NCITLB meetings, improving attendance for the NCITLB meetings

- Rachel very willing to share feedback and input regarding educational interpreting.
- Joni alternating meeting dates so that there's a variety of days of the week offered to allow varied attendance.
- Danette Mark's commitment is appreciated for this role.
 Wondering about the willingness of the NCITLB to meet at alternate times. Mark the staff and attorney serve at the will of the board, and are paid by the board so more flexibility in dates/times should be coming.
 - LRC Licensing Review Committee, wants to see this committee truly review complaints because the view in the community is that nothing happens so why complain? Looking into more virtual options for increased accessibility with the LRC and complaint process
 - Provisional renewals limiting that, the law says 3 renewals meaning the 4th year it should lapse or you obtain a full license. Far too many extensions have been granted.
 - Sunsetting previous issue with this and one reason was due to the lack of complaints and therefore a necessity of the actual licensing board
