- Conference Actual Profit \$635.61
 - Total \$6,121.51 (including seed money for next year's conference)
- Presenters must fill out W-9 (Trula has sent W-9s out to new reps)
- Membership Report
 - Regional Report sent out to reps
 - Trula will send out an email in August as a last call for those that haven't renewed
 - 192 Members 120 Voting, 47 Non-Voting, 22 Students, 3 Organizations
 - 153 Renewals, 36, New
 - Total Membership Last Year 286
- Antwan Info for New Reps
 - Can have committees still, can have someone who works with the finances (in contact with Trula), can have CMP people (in contact with Kayla), if you want to help out with Committee, you can be in contact with Joni - Point: you are not an army of one. You CAN have committees! They are just not a part of this board.
 - Melissa Do the committee members have to be NCRID Members?
 - They should be, but it's not heavily policed
 - Used to have local chapters, but that is no longer allowed. Now only the Regional Reps have "power," but you can still have committees.
 - Co-chairs only equal to one vote
 - If you are a member of NCRID, you are a member of all regions, so you can attend any workshops across the state
- Kayla CMP Report
 - Everything running smoothly
 - Reminder texting Kayla may be faster than email
 - o Some issues with RID Transcripts at Conference contact RID CMP Person
 - Open to feedback new to the position
 - No longer processing PENRAs at the NCRID level (outstanding states may process, but we will no longer be processing them)
 - Kayla will send out forms for CMP processing and checklist to new Reps
 - 45 days prior to the event, closing paperwork sent within 45 days after the event
- Conference Report
 - o Ideas for 2020
 - Tanya to co-chair
 - Thank you to Eastern
 - This year will be their last conference working with planning

- Looking for a new conference chair
- Next year will be a two day conference
 - Danette Maybe do a bi-annual conference
 - By-laws say we must have an annual "meeting," doesn't have to be a conference
 - 10% must be voting members to meet quorum (general business, by-law changes must have 51% for quorum)
 - Board Decision (next year)
 - If we change to bi-annual, the conference needs to happen on the year that the executive board elections happen
- Will send out a call for help with Conference
- Total Budget for Conference \$30,000
 - Income \$52,708.68, Expenses \$46,579.17
 - 197 Participants at Conference
- Trula has more detailed report
- Eastern has hosted 2 years in a row, Coastal is next to host
- Communication in planning for conference
 - All involved thus far (approx 6) that have been involved have lived near one another and have met face-to-face every two weeks (closer to conference)
 - Some things have been done via phone and email, but really need to meet face-to-face
 - Media, CMP, Treasurer, Student Rep, Outreach/Sponsorships, Registration, and Conference Chair
 - Please send out positions and descriptions
- Mark Idea for a "no-frills" conference in the off-year
- NCRID Stipend
 - For interpreters taking a national test
 - EIPA, NIC Written or Performance
 - One time request
 - Before: \$75, would like to increase to \$100
 - From Mikki Simpson fund people can donate to this fund
 - Deaf woman from Morganton, President of NCRID, very supportive of interpreters, Foothills started a fund in her name
 - Current amount in fund: \$1,167.42
 - Applications starting new now, previous times not accounted for
 - If you successfully pass your test, NCRID will reimburse you
 - Must be a member of NCRID prior to applying
 - Can apply on the website simple application
 - Can apply within 45 days after receiving results
 - Motion to increase to stipend to \$100, and the stipulation that applicant must apply 45 days - Stacy
 - Second Caroline

- Antwan President's Report
 - RID Conference
 - More flexible schedule than previous year
 - Affiliate Chapters
 - No more retreat requirements
 - New requirements for President, Treasurer, and Secretary
 - Only must submit minutes and 990
 - New position at HQ Affiliate Chapter Liaison Carolyn Ball
 - Sent out motions that were passed at conference via e-mail, please check them to vote on them!
 - Board Structure is different now
 - Trying to move to online voting for membership for fairness
 - Region II Conference is this year at Richmond, VA July 16-19, 2020
 - Offer over 2.0 CEUs
 - o Projected to be less than \$200
 - Breakout sessions and CDI workshops
 - Planned to be at Marriott on the water
 - Antwan is on the certification committee, so he got great info on that at conference
 - Looking at an outside agency (neutral party NCCA) to vet other tests, if these other tests are approved that change will be made and we will use that test (like BEI, EIPA), if outside tests meeting approval, they will be recognized by RID
 - Current EIPA will not be recognized, however if EIPA process changes to match RID's professional development process (require CEUs), then they will pass
 - New CASLI tests will be released in 2020
 - Another plan is to move to remove all of the letters/acronyms from the interpreter's' title and instead say "Jane Doe, certified interpreter since 1909"
 - Antwan will not be President next year, but would like to attend to support the new President
 - Will be a community day/forum/community appreciation event sponsored by CSDHH - Thursday, December 5
 - Looking for a representative from NCRID to attend and give a 5-10 minute presentation if anyone wants to volunteer
 - Joni we would like to see a presentation/plan beforehand
 - Will see if someone will agree to first, and then will ask for that

- Deaf and HoH Council NCRID representative position open Next is November 15, meet quarterly
 - Governor appointed council
 - Send out to membership, contact Antwan
- Last meeting (yesterday)
 - ITP and Community College teaching ASL Classes
 - Approx 300 Nationally Certified interpreters, 500 licensed interpreters
 - High need for interpreters
 - Looking at trying to ask more Deaf people to teach ASL in high schools
 - Need ASLTA Cert and 4 year degree
 - Community College does not have these same requirements for teaching ASL in Colleges
 - Council is meeting to develop some requirements for that
 - NCRID's opinion?
 - Letter of support?
 - Table until a decision is made
 - Motion to write a letter of support in Deaf and HoH Council's decision about providing more ASL classes in community colleges/high schools and if so, that they hire qualified teachers for this - Danette
 - o Second Trula
 - Discussion about supporting writing the letter vs what the letter will say specifically
 - Danette withdraws the motion
 - Will discuss via email after the decision is made and we can decide before our next meeting - do not have to have a formal motion
 - Licensure for Educational Interpreters
 - Currently they are excused from the licensure law
 - Many problems because there is no requirements for educational/post-secondary interpreters
 - K-12 has started following EIPA, Post-secondary has not
 - DPI is on board with adding them to the licensure board, but we have not made a final decision. Meeting on Tuesday to either develop a separate license for DPI, or for educational interpreters to be added to NCITLB
 - Licensure Board meeting is August 23
 - Many groups will be coming to make a decision about this
 - Rep from NCRID? Mark on standby
- Rachel Skipper
 - Unlicensed interpreters are being hired via a new Purple center in Charlotte

- NCITLB has no control of this because VRS Centers are governed by the FCC (is current info). NCITLB is fighting it, but Purple is saying Federal Law supercedes state law
- Please send all complaints to the FCC
- Currently there is no federal law about licensure
- NCAD will be informed
- Trula can we write a letter from NCRID to the FCC to inform them and that we do not support that
 - Motion to write the letter Trula
 - Second Melissa
 - All in favor
 - Jessica to draft the letter working with Rachel, Antwan to sign
- Melissa question about how outside agencies find out our licensure law
 - Antwan we are informing some agencies, but have not been able to inform all
 - o ADA also clarifies what is a qualified interpreter
- Next Meeting

 - Change meeting location to Heritage Green for November
- Goals for the Year
 - Previous goals (accomplished!)

 - Trula Close NCRID's mentorship program DSDHH offers one and we can't afford it on our own
 - Antwan DPI also has a mentorship program
 - Motion to dissolve NCRID's mentorship program Trula
 - Second Stacy
 - No discussion
 - All in favor, motion passes
 - Marketing/Promote NCRID
 - Better job putting out information of what we offer (such as the Stipend)
 - Question about Workshops being added to calendar online -Process is: Paperwork through CMP, CMP approves the flier, then flier forwards to Media - Contact Taylor
 - Collaboration with the Deaf Community
 - NCRID should have more of a presence at these events

 - Going out and talking about NCRID throughout the state
 - Maybe link up with NCAD
 - Who are NCAD's Regional Reps?
- Do we want to have a retreat? No
- Encourage Regional Reps to collaborate and communicate with one another
